

Privacy policy

Under the GDPR law this statement outlines the use of how your data is processed, disclosed and managed. This privacy policy defines the legal requirement to protect you as a consumer visiting my website and purchasing from my shop.

What type of information I collect?

In order for the consumer to purchase from my website, I collect the information in which they enter themselves on the website. This personal identifiable information includes their email address, full name (first name and last name), password, address and billing details. Also, their comments, feedback and general enquiry and profile on my website. Payment details are provided through an extension website called "stripe", which is connected to my website.

How do I collect information?

When consumers purchase products from my website, I collect their personal information in which they fill out the form within their account set up, such as full name, address and email address. This information is only used for purchasing products and to enable a consumer to order again with their own account set up saved for future use. When consumers message me through my contact form, I collect their personal information in which they fill out on the form this is name and email address only. I do not have a subscription for newsletter yet, but when this is apparent I will alter the privacy policy. No data is collected to use to contact the consumer when they are unaware, only used for replying to a message or for purchasing products.

Why do you collect personal information?

Personal information is collected for purchasing purposes and contact for enquiry. I collect personal information to operate the website, in order for the consumer to receive their products and communicate with myself.

How do you store, use consumers personal information?

The website I have created www.maysummersperkins.co.uk is hosted on Wix.com platform, Wix.com provides the online platform in order to showcase my work, sell my products and communicate with the consumer. Your data is stored through Wix.com data storage, databases and the general Wix.com applications. This data is stored on secure servers behind a firewall. All direct payment gateways offered by Wix.com and used by our company adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers. Email correspondence is stored securely within my storage, this information is not shared with anyone other than myself and the consumer.

How do you communicate with your site visitors?

I communicate with site visitors and consumers to answer enquiries and if applicable to deal with any purchasing issues. This is carried out by email only, which has already been provided by the consumer.

The use of cookies within your site?

The use of cookies within my site are used to provide the services and feature offered on my website and improves the user experience. This is apparent by a pop up at the bottom of the screen, in which the consumer can click they have "got it". Consumers are welcome to find out more information by clicking the link which takes them to a site which is a guide about cookies and how to control and delete them if they wish. This is a third-party service and will have its own policy regarding the way it collects and stores information. As this is an external service, this is not covered in my privacy policy.

How can a site visitor or consumer withdraw their consent?

A site visitor or consumer may withdraw their consent for collection of their personal information, by emailing me directly so that I am aware that you don't want me to process your data anymore.
